The complainant, being first duly sworn on oath, on information and belief, alleges and states that in the County of Racine, State of Wisconsin, the defendant did commit the above described offense(s) and prays that said defendant be dealt with according to the laws of the State of Wisconsin.

The complainant states that he is an adult citizen and has reviewed the official law enforcement reports prepared under the above mentioned complaint numbers by the above stated officer(s), whose reports your complainant relies upon as truthful and accurate inasmuch as they were prepared during the course of an official law enforcement investigation. The complainant relies upon the statements of the mentioned witnesses inasmuch as they are citizens and their statements are based on personal knowledge

or eyewitness observations; the complainant relies upon the statements of the defendant, if any, inasmuch as they are contrary to the defendant's penal interests and are, therefore, to be believed.

# The complainant thereby informs the court that the basis for the above charge(s) is as follows:

Dep. Venegas of the Racine County Sheriff's Office reports that on February 28, 2021, she was dispatched to a residence in the Village of Rochester for a report of a sexual assault. The alleged victim, identified as JB, stated that she had found videos on a laptop belonging to her ex-boyfriend, identified as Shane STANGER, which showed STANGER repeatedly sexually assaulting her without her consent. JB stated these videos were from 2015 to the present and the assaults would have taken place at her residence in the Village of Waterford, Count of Racine, State of Wisconsin.

Dep. Venegas reports that upon making contact with JB, JB stated that she believed that STANGER had been drugging her and sexually assaulting her in her sleep. JB stated she did not take any medications that would prevent her from waking up and she has no recollection of the assaults shown on the video recordings she discovered. JB stated she did recognize herself and STANGER in the videos as well as the sheets on their bed. JB stated she also has two children with STANGER but they have not been romantically involved since 2015, making this a domestic incident. JB then provided to Dep. Venegas a flash drive on which JB saved the videos she observed on STANGER's computer.

Dep. Venegas reports that she viewed the videos contained on the flash driver. In the videos, it appeared that STANGER is doing the camera work as he performed sexual acts on JB.

J.B. stated regarding the below mentioned conduct that at no time did she

consent to be drugged, engage in any kind of sexual contact in an unconscious condition, to include, but not limited to; anal sex, digital anal penetration, or anal penetration with any object. J.B. also stated she didn't consent at anytime during the relationship to be video recorded and those videos to be stored.

### COUNTS 1-10 2nd Degree Sexual Assault of an Unconscious Victim (Domestic Abuse)

J.B. indicates that in November 2015 she moved to the Village of Waterford, Racine County, WI address. She lived there until April 2019. In reviewing Stanger's laptop and cellphone, Inv. A. Sparks advises on 10 occasions between November 2015 and April 30, 2019, Stanger had sexual contact or intercourse with J.B. while she was unconscious at her Village of Waterford address. Having reviewed the videos, Inv. Sparks advises J.B. was unconscious in the videos because of J.B.'s snoring respirations, little to no response to any of Stanger's repeated assaults and J.B. only responding to painful stimuli, as well as no physical response at all when being physically moved by Stanger. In the below videos Stanger is referred to as "SS" and the victim as "J.B."

Occurred on 6/09/2020, on 5 separate occasions in the Village of Rochester address wherein Stanger again captured J.B. in a nude state, either exposing her buttocks, public area, anus, or breasts without consent, as well as invaded her privacy without her consent by intentionally viewing those nude areas of her body without her consent.

### COUNTS 38-43 Possession of Child Pornography

Inv. L. Johnson advises that he drafted two search warrants for digital analysis of Stanger's Toshiba laptop and Samsung Android cell phone. The laptop was in the Village of Rochester residence and the cell phone was taken as evidence upon Stanger's arrest in the City of Burlington, both of these devices were in Stanger's possession at these addresses in 2021. Both addresses are in Racine County, WI.

Inv. A. Sparks advises that he drafted one search warrant for digital analysis of a SanDisk SD card located within the residence in the Village of Rochester.

Shane Stanger has accumulated over 21 videos including two of which he can be seen sexually assaulting a victim who is 10 years old. The remainder of these videos depict females ranging from ages 6 to 17 in

various stages of undress and using the bathroom. The purpose of these videos is for Stanger's own sexual gratification as they were retained on his devices as of the year 2021.

Examination of the files from Stanger's cell phone reflected in counts 38 & 39 above show that there are two recorded videos of a juvenile, identified as P.C., date of birth 8/5/10, who was 10 years old at the time of the recording. The recording took place on 1/12/21 and 1/15/21. The recording shows a male hand moving the young girl's underwear around and the male adult hand digitally penetrating the girl's vagina. The girl, P.C., is the daughter of Stanger's girlfriend, M.R., who resides in Bettendorf, Iowa. M.R. found P.C.'s underwear, advising it's the same underwear shown in the video. The underwear was collected and is in evidence in Iowa. While being present in the Village of Rochester on February 28, 2021, Stanger possessed the recordings of a child he knew to be under the age of 18 years while he was sexually exploiting this minor child.

#### Videos from Stanger's laptop

Examination of files from Stanger's laptop reflected there were three recorded videos of a juvenile, identified as M.C., DOB 12/30/2005. These videos are described as follows:

It appears the camera is near the door, possibly on the vanity. It is pointed towards the shower and toilet. The video stops. Taken in context of Stanger's other video recordings of intimate parts of his victims, this recording meets the definition of child pornography for sexually explicit conduct of lewd exhibition of intimate parts because of Stanger's possession of an under age victim with a camera pointed at the toilet where the focus is on a less than fully covered intimate parts of a child in a way that places an unusual focus on the intimate parts because the angle is on the child using the toilet per Wis. Stat. 948.01(1t).

In the beginning Stanger is observed setting up the camera and positions it facing the toilet and shower. From this point she completely disrobes exposing her pubic area, breasts, and buttocks. She then enters the shower and at duration 14:06 she opens the shower curtain and exposes herself once more. She then dries off with an orange towel and leaves the bathroom. Stanger then enters the bathroom and removes the camera and lays down on bed in MR's bedroom. The video stops. Again due to the unusual focus of the video at the shower wherein a child is depicted disrobing, on Stanger's device, this image is alleged to be child pornography.

buttocks. She enters the shower and at duration 06:10 she exits the shower again exposing herself. She drives off with an orange towel and leaves the bathroom. The video stops. Due to the focus on the child taking a shower in the context of the other images possessed on Stanger's devise, this video is alleged to be child pornography.

Videos from Stanger's SD card

Examination of files from a SD card recovered from Stanger's possessions at the residence in the Village of Rochester reflected a video that contained three juveniles, identified as, J.S., DOB 02/20/2013, P.C., DOB 08/05/2010, B.U. 03/19/2015.

During the examination of evidence on Shane M Stanger's laptop (Toshiba Qosmio SN#B8014753H), Inv. Sparks observed several videos that appeared to have been captured in a workplace employee bathroom, in an area not used by the public, at Michael's on the Lake 3101 Eagle Rd., Town of Dover, County of Racine, where Stanger was employed as a bartender from approx. 02/19/2020 to the time of his arrest, 3/1/2021. Inside the bathroom, on the opposite wall of the toilet is a coat rack where it appears that Stanger would place the camera that he used.

All the of victims mentioned below indicated that they gave no consent to be recorded or for any depictions of nudity to be saved onto any device and they each identified themselves.

## COUNT 82 Stalking (Domestic Abuse) Victim J.B.

Shane Stanger engaged in the following course of conduct

J.B. contacted Inv. Sparks on or about March 1, 2021, stating she found a camera in her bedroom under some clothes and pointed towards her bed. The camera was recovered later that week and placed into evidence. On Stanger's phone there were two photos in his gallery that were taken on February 28, 2021 1:45 p.m. and

February 28, 2021 12:14 p.m., on the photos a date and time stamp of 2021-03-01 08:35:12 and 2021 -03-01 02:14:22 respectively. JB advises the photos are of her bedroom in the Village of Rochester, Racine County, WI. It is believed that Stanger was stalking JB by engaging in a course of conduct, using an electronic means (IP camera) to monitor and/or recording JB's activities, specifically Her in her bedroom by recording himself numerous times sexually assaulting JB, including sending the below described letter to her, using another inmate's information as the sender/return addressee.

## Count 83 Intimidation of a Victim - Felony (Domestic Abuse) Victim J.B.

On April 5, 2021, JB contacted Inv. Sparks to advise that SHANE STANGER sent her an eleven-page letter from the jail. While he made it appear to be from another inmate, JE, part of the letter was to their children and it was signed "Dad Shane Stanger". The portions of the letter addressed to JB direct her to recant her statement "Just remember this slogan I made for you, If you say you cant cause its out of your hand just RE-CANT. When they ask in trial Don't say I can't-- just Recant Lol. So basically recant your story and get me out of this mess." "And I pray you re-cant (recant) your story, let them know you were hung over pissed off and not a morning person and your emotions got the best of you." "...but (name redacted), (second name redacted), anyone else who has crossed me then will be facing tough times soon..." "I got carried away with that stupid drug..." "There is a guy in jail who killed 3 ppl and his bond is only 100,000, mine is 5 million because I was so in love with you I recorded everything in case I ever lost you, so I would still have every piece of you in my mind." JB indicated she took the statements in the letter to be implied threats of violence and that his letter caused her serious emotional distress.

### Count 84 Intimidation of Victim – Felony (Threats) Victim M.R.

On 4/21/2021, Inv. Sparks received an email from a Detective from the Bettendorf, Iowa Police Department with the contents of a letter that was sent from the Racine County Jail by Stanger to victim M.R. in Bettendorf, Iowa, who was also recorded while unconscious, being raped by Stanger. This victim is also the mother of the 10-year-old child who Stanger sexually assaulted and recorded himself doing so, thus creating the sexually explicated images of the child. Just like the letter sent to JB, the return addressee was another inmate, J.E. Just like the letter sent to JB, Stanger threatens MR if she does not do what he wants. "...well unfortunately for me, I still need you, so no matter what your scared of w/the girls dad or Sparks, I can and will destroy your life way worse than either one of those 2 could..." "So unless you want to end up without your girls and in jail as well, your gonna have to communicate w/me and help me out still for a bit..." "...I have a letter wrote detailing all about that wonderful drug we did and even with your girls there..." "...and I have one for Sparks on that detailing where he can find certain things that will put you right where I am (in hell)..." "...you dont get to run and hide anymore you have a choice help me or lose everything!" "Really you gonna turn on me and give the underwear, when you could have just as easy said it wasn't her, and definitely not give something to incriminate me for something I truly..."

"...Im going to give you until 4/20 though to hear from you, and if not I send the first letter out to Norfolk, I hate that you have made me have to do this..." "So look at this way, what happens when you can longer talk to your kids?" "So like I said in the beggining no matter what they have said to you Theres always ways around it!"

"Either way though I have to survive so if I don't hear from you I WILL GO through with my next phase of my plan!" "Like I said you will lose girls + much much more!" The letter was signed "Shane".

Just like JB, MR took the threats in the letter from Stanger to include threats of physical violence and caused her serious emotional distress.
